Public consultation on the product scope of the EU Timber Regulation

Fields marked with * are mandatory.

Introduction

This public consultation is part of the <u>impact assessment</u> being undertaken by the European Commission to inform a possible change to the product scope of the EU Timber Regulation (Regulation (EU) No 995 /2010) (EUTR).

The EUTR prohibits the placement of illegally harvested timber on the EU market. For that purpose, it obliges "operators" (those who first place timber products on the EU market) to exercise due diligence to minimise the risk to source illegal timber. It also obliges "traders" (those further down the supply chain) to keep records of their direct suppliers and customers. The EUTR applies to both domestically produced and imported timber products that are listed in its Annex. The Annex defines the product coverage using a combination of references to codes from the EU Combined Nomenclature (CN) and description of products.

The Commission has evaluated the effectiveness and functioning of the EUTR during its first two years of application. The findings were presented in February 2016 in a report to the Council and the European Parliament available at http://ec.europa.eu/environment/forests/eutr_report.htm. The evaluation noted that the EUTR covers a significant number of timber products, but not all are included in its scope. Some timber-based products, such as musical instruments or wooden seats, are not covered. In terms of market share, an important group of products currently exempted is printed paper (such as books, newspapers, manuscripts, typescripts and plans). Unlike domestically printed media, where imported pulp and paper material is controlled for legality, imported printed media are not subject to checks for the legality of wood fibres imbedded in them. Therefore, they may carry a higher risk of originating from illegally harvested timber.

Consultations with stakeholders have shown that many do not consider the current EUTR product scope optimal and feel it should include more timber products. However, others consider that the product coverage should not be expanded before the EUTR is fully implemented and effectively applied. The stakeholders have also pointed to the fact that the EUTR covers some products made of bamboo, i.e. a non-wooden material, while other bamboo-based products are explicitly exempted from the scope. They have suggested considering their consistent removal from the product scope because bamboo-based products are not made of wood.

The evaluation concluded that the Commission may consider expanding the product scope, subject to an impact assessment of options. The European Commission is therefore undertaking an impact assessment to analyse possible changes to the EUTR product scope. Three policy options are being considered. The first option is to continue operating under the current EUTR product scope **without any changes**. The second option is to amend the product scope to **include one or more** additional categories of products. The third policy option is to amend the product scope to **include all** products that contain timber and, if appropriate, provide for a **list of exemptions** (as it is the case now with recycled timber and timber products). Each policy option may also involve the possibility to **remove products** which are currently covered by the regulation.

The impact assessment aims to inform stakeholders and others about the Commission's work to allow them to provide feedback on the envisaged initiative and to participate effectively through consultation activities. Through this public consultation, you are invited to provide your views on the issue, the proposed options and the range of likely impacts for each of the options.

Your responses, along with those from other citizens and stakeholders, will be taken into account in the impact assessment. It is therefore important that you complete this questionnaire as fully as possible. Responses can be provided in any EU official language.

The survey has three sections and takes around 20 minutes to complete. It will be available online for twelve weeks starting from 29 January 2018 and closing on 24 April 2018.
